WIOV-FM's "UGLY CHRISTMAS SWEATER FACEBOOK RTW - NOVEMBER 18-22, 2024" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WIOV-FM ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station website www.wiov.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WIOV-FM's "Ugly Christmas Sweater Facebook RTW - November 18-22, 2024" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. - 2. Contest Period. The Contest entry period will begin at 6:00 AM ET on November 18, 2024 and will run until 9:00 AM ET on November 22, 2024. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter. Visit the Station's Facebook page at www.facebook.com/i105wiov during the Contest Period, look for the first Ugly Christmas Sweater post, and enter the contest by posting a photo of yourself in an "Ugly Christmas Sweater" in the comments on that post. All comments to the post are automatically entered in the contest. All entries must be received by 9:00 AM ET on November 22, 2024 to be eligible for a chance to win a prize. Limit one (1) entry per person, regardless of how many email addresses or Facebook accounts a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this

promotion. No mail-in entries will be accepted. This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook.

- 4. Winner Selection. On or about 9:00 AM ET on November 22, 2024, the Station will select three (3) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. After the three (3) winners are selected, the Station will conduct a second random drawing from among those winners to choose one (1) grand prize winner. Each winning entrant will be contacted using the Facebook account provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner.
